Within 24 Hours <i>Election Cycle Reports</i>	1/16/19 – 3/26/19 <i>(March 26 Special Primary)</i> 3/6/19 – 6/4/19 <i>(June 4 Special General)</i>	497	- E-File only – no paper copy is required. - File if a contribution of \$1,000 or more in the aggregate is received from a single source. - File if a contribution of \$1,000 or more in the aggregate is made to a candidate being voted upon in the March 26 or June 4 elections, or to a political party committee. - The recipient of an in-kind or non-monetary contribution must file a Form 497 within 48 hours from the time the in-kind or non-monetary contribution is received.
Feb 14, 2019 <i>1st Pre-Election (Special Primary)</i>	1/1/19 – 2/9/19	460	All committees must file this report.
Mar 14, 2019 <i>2nd Pre-Election (Special Primary)</i>	2/10/19 – 3/9/19	460	- All committees must file this report. - Paper copies must be filed by personal delivery or guaranteed overnight service only.
Apr 25, 2019 <i>1st Pre-Election (Special General)</i>	3/10/19 – 4/20/19	460	- Candidates who were unsuccessful in the March 26 election do not file this report. - All other committees must file this report.
May 23, 2019 <i>2nd Pre-Election (Special General)</i>	4/21/19 – 5/18/19	460	- Candidates who were unsuccessful in the March 26 election do not file this report. - All other committees must file this report. - Paper copies must be filed by personal delivery or guaranteed overnight service only.
Jul 31, 2019 <i>Semi-Annual</i>	* – 6/30/19	460	All committees must file unless the committee filed termination Forms 410 and 460 on or before June 30, 2019.

Additional Reports:

Depending on committee activity, the following report may also be required:

- **Form E-530:** File within 48 hours of making a payment of \$50,000 or more during the 45 days prior to an election for a communication that identifies a state candidate being voted upon in the election but does not expressly advocate the election or defeat of the candidate. No paper copy is required.

Additional Notes:

- *** Period Covered:** The period covered by any statement begins on the day after the closing date of the last statement filed, or January 1 if no previous statement has been filed.
- **Deadline Extensions:** Deadlines are extended when they fall on a Saturday, Sunday, or an official state holiday. This extension does not apply to any 24-hour contribution reports (Form 497) that are due the weekend before the election. Such reports must be filed within 24 hours regardless of the day of the week and are subject to a \$10 per day late fine.
- **Where to File:** State committees file reports with the Secretary of State. Only candidate controlled committees that are not e-filers file paper copies with the elections official at the candidate's county of domicile.
- **E-Filer:** A state committee that has received contributions or made expenditures totaling \$25,000 or more.
- **Form 460:** All state committees, including e-filers, must file paper reports.
- **Paper Filings:** All paper filings may be filed by first class mail unless otherwise noted.
- **Form 497:** All reports filed online only.
- Committees making independent expenditures totaling \$1,000 or more to support or oppose other candidates also file:
 - **Form 462:** This verification form must be e-mailed to the FPPC within 10 days.
 - **Form 496:** This form is due within 24 hours if made in the 90-day, 24-hour reporting period of the candidate's election. Refer to the applicable filing schedule. Form 496 is filed with the filing officer in the jurisdiction of the affected candidate.
- **Multiple Committees:** All committees controlled by a state candidate listed on the March 26 and June 4 ballots must file statements on the pre-election filing deadlines, in addition to the committee formed for this election. For example, a candidate for Senate listed on the June 4, 2019 ballot who maintains an Assembly officeholder committee must file pre-election reports for both committees even if the Assembly committee has not received or made payments.
- **Contribution Limits:** Refer to the [contribution limits chart](#) on the FPPC website.
- **Penalties:** Late statements are subject to a fine of \$10 per day on both the paper and the e-filed version, i.e. \$20 per day for a late Form 460. Failure to file a statement could result in an enforcement penalty of \$5,000 per violation.
- **Public Documents:** All statements are public documents.
